



Terms and Conditions

PAYMENTS

Certain Occasions may carry their own schedule. If so, they will be outlined in the details. Otherwise, schedules for deposits and final payments are:

Deposits: A non-refundable deposit of 30% of the Occasion's cost per person is necessary to begin making the arrangements for your Itinerary. All reservations for accommodations, tee times, transportation and any additional event elements of your Occasion are subject to availability. Personal check, company check, bank draft, wire transfer, VISA, Amex, Master-card and Pay-Pal are accepted. Reservations may be made over a period of time and necessitate additional partial deposits.

Balances: The balance for your Occasion is due 60 days prior to departure.

INSURANCE

We encourage Travel insurance for accident, baggage and trip cancellation protection.

CANCELLATIONS

We should be notified in writing of any cancellations as soon as possible. Our standard cancellation charges are stated here but can vary by Occasion. If they differ materially, they will be outlined on your itinerary materials.

Deposits: are not refundable.

Payments: 50% is not refundable when cancelled within 60 and 31 days of departure.

75% is not refundable when cancelled within 30 days of departure.

100% is not refundable when cancelled within 15 days of departure.

OUR LIABILITY TO YOU

We can not be liable for loss, damage or theft of luggage or personal belongings, for personal injury, accident or illness on any vehicle or at any place during your Occasion.

JURISDICTION

We also reserve the right to cancel an Occasion if circumstances so require. In that event, we will make a full refund. This Agreement shall be governed by the laws of the State of Delaware. The parties irrevocably agree that any judicial proceedings relating to this agreement will be filed in a court of competent jurisdiction within New Castle County, Delaware.



Terms and Conditions

COURSE SELECTION

All golf is subject to course availability. In the event a particular course becomes unavailable, we will endeavor to find a comparable playing opportunity.

CARTS

Pull carts are available at most courses. Motorized carts are available on a limited basis and must be requested in advance and cannot be guaranteed. In many cases carts are only available with proof of a disability. The golfer will pay cart fees directly to the Golf Club. In some cases carts are at no-charge and a caddie is assigned as the driver and the player pays the caddy the appropriate fee.

CADDIES

Caddies can be requested in advance at most golf clubs. Unless we make earlier arrangements, payments are made directly to the Golf club or caddie. Fees for caddies that are requested and not utilized may become the responsibility of the golfer (s) in the group.

HANDICAPS

It is required, although not always enforced, that all golfers carry a current handicap certificate. Certain maximum handicap restrictions may apply.

PRICES

All Occasion pricing is provided in U.S. Dollars and is subject to change based on currency fluctuations. Others adjustments may also have to be made caused by the availability of accommodations, tee times and other arranged elements.

CHANGES

Once a program has been booked and confirmed, an administrative fee of \$100.00 may be charged for each subsequent change in the tour. Name transfers or substitutions are often not allowed by certain vendors. If a party changes participant names and a Golf venue prohibits that, any non-refundable deposit made to that club, may be charged back to the party.

VEHICLES

Where guests drive themselves, valid and in certain countries, International licenses are required. Minimum age is usually 25 and some countries state a maximum driving age. Please remember to designate automatic or stick shift.
